It was an odd and interesting year to be in a leadership position. We chose a cautious path regarding Covid-19, always allowing for those who did not want to attend meetings in person to do so virtually. The mostly virtual board meetings and full-virtual installation of officers allowed us to complete the work necessary to serve our members. But I believe we all want to get back to meetings as usual. I hope you all have a better and safe 2021.



Al Board of Directors Approves 45-Day Notice Item on Agenda During November Meeting

The Appraisal Institute Board of Directors adopted one 45-Day Notice item on its agenda during its Nov.12-13 meeting, which was conducted via videoconference due to the coronavirus pandemic.

The Board adopted the proposed amendments to the Appraisal Institute Bylaws concerning the Audit Committee as set forth in the 45-Day Notice distributed to Designated Members, Candidates, Practicing Affiliates and Affiliates on Sept. 28.

The Board also directed that the 45-Day Notice of proposed amendments to the Code of Professional Ethics be referred back to the Professional Standards and Guidance Committee for further study.

IN MEMORIAM

Richard "Dick" E. Nichols, MAI, SRA

Richard E. Nichols, MAI, SRA passed away October 27, 2020. He obtained a Bachelor's Degree from the University of Illinois and a Master's Degree in Agricultural Economics from Purdue University. He worked for three years for the Indiana Highway Commission as an appraiser and chief review appraiser before going into business with other real estate appraisers. He ultimately formed his own company, Richard E. Nichols and Associates, located in Indianapolis, Indiana. He served as the President of the Society of Real Estate Appraisers in 1985. He became a member of the Appraisal Institute after the merger with the Society of Real Estate Appraisers and was also a member of Farm Managers and Rural Appraisers, the American Right-of-Way Association, and the Real Estate Counseling Group. He chaired the National Appraisal Foundation and the Indiana Real Estate Appraisal Licensing Board. He was named a Sagamore of the Wabash by Indiana Gov. Robert Orr.

Mr. Nichols received the "Hall of Fame Award" by Chapter V of the Society of Real Estate Appraisers in 1986. In 2007, the award was reinstated and renamed the Richard E. Nichols, MAI, SRA Lifetime Achievement Award as a tribute to its first recipient. The award was established to recognize those individuals who exemplify Mr. Nichols' high level of service and many contributions to the Appraisal Institute, the appraisal profession, and the community as a member of the Hoosier State Chapter.
